2.	Promoter’s details:	This Competition is conducted and organized by Cradlestone Mall (“ Mall ”) and offered by Sasol Pension Fund & Redefine (“ Landlord ”). In these T’s & C’s we refer to the above promoter(s) as “the Landlord” and the entrants as “the Participant(s)” or “you”.
3.	IMPORTANT INFORMATION	
4.	<u>Eligibility:</u> Who may enter the Competition?”	To enter the Competition, a Participant must be: 18 years or older and in possession of a valid South African identity document or passport;
5.	Who cannot enter the Competition?	The Competition may not be entered into by any director, member, partner, employee, agent, consultant, tenant of the Landlord at the Mall, the marketing service providers and/or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
6.	Competition Period:	The Competition will run from 25 October 2024 until 20 November 2024 (“ Competition Period ”). Any entries received after a Competition Period will not be taken into consideration.

8.	Limitation on entries	A Participant may enter as many times as s/he wishes during the Competition Period and can only win once per draw.
